**4. TERM/TERMINATION.** This Agreement shall terminate on October 26, 2008.

**5. RELATIONSHIP OF PARTIES.** It is understood by the parties that The Sponsor is an independent contractor with respect to The Foundation, and not an employee of The Foundation. The Foundation will not provide fringe benefits, including health insurance benefits, paid vacation, or any other employee benefit, for the benefit of The Sponsor.

**6. INJURIES.** The Sponsor acknowledges The Sponsor's obligation to obtain appropriate insurance coverage for the benefit of The Sponsor (and The Sponsor's employees, if any). The Sponsor waives any rights to recovery from The Foundation for any injuries that The Sponsor (and/or The Sponsor's employees) may sustain while performing services under this Agreement and that are a result of the negligence of The Sponsor or The Sponsor's employees.

**7. ENTIRE AGREEMENT.** This Agreement contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written.

**8. SEVERABILITY.** If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

**9. APPLICABLE LAW.** This Agreement shall be governed by the laws of the State of Texas.
